1. General

2. What information do you collect about me?

We collect data that you submit to us such as your name, address, phone number, email address, and payment information. We also collect data that is submitted to us automatically such as location data, IP address, data provided by cookies and other similar technologies.

3. Why do you need my information?

We use the data you provide to generate invoices and communicate with you, for example, informing you about your booking, late availability offers, new services, and other forms of email marketing.

4. How is my information used?

We use data for the following purposes:

- Customer support
- Generation of invoices
- Communication and marketing, including responding to customer enquiries and providing you with directions and other instructions for your upcoming holiday.

5. Analysis of collected data

We use aggregate collected data for analysis that allows us to monitor visits to our website thus providing information for future email communications or campaigns.

6. Communication, Marketing and Advertising

We use the data we collect to deliver and personalise our communications with you. For example, we may contact you by email to inform you about new services, late availabilities, special offers and competitions.

7. Do you sell information to third parties?

8. How We May Share Personal Information

We do not sell or pass on personal information about our customers. We may share information with the following types of third parties:

8.1 Third Party Vendors

We may use third-party vendors to carry out services like website hosting and credit card processing. We only share your personal data as necessary. We will retain your personal data only as long as is necessary for the purposes to which you consent under our terms

and conditions and this Privacy Policy, or as is required by applicable law, and then we will delete it. We will completely delete any personal data held if you unsubscribe from our website subscription by contacting us at

13. How is information stored and secured?

We are committed to protecting the security of your personal data. We store the personal data you provide on a

computer that has limited access and has password protection, with no paper records held.
